The pairing rules may be waived, at the discretion of the board of directors, if there are an insufficient number of co-anglers participating in a tournament. In this event, boaters and co-anglers will be paired randomly until all the co-angler pairings are made. The remaining boaters that have not been paired with a co-angler will be allowed to choose to either fish alone or to be paired with another boater.

TOURNAMENT EXPENSE SHARING

The amount the co-angler shall give to the boater as his share of tournament expenses shall be: (1) \$60 for Pleasant, Bartlett, Canyon, and Saguaro Lakes; (2) \$90 for Apache, Alamo and Roosevelt Lakes and (3) \$120 Havasu, and Martinez Lakes.
